Subject: Support of 'Resource Center' with E-Verify Condition

Dear Mayor Clemons:

Floridians for Immigration Enforcement (FLIMEN), residents of Lake Worth, and the overwhelming majority of US citizens are distressed with the continuing massive problem of illegal immigration and the failure of all elected officials at all levels to deal with the problem. Illegal immigration has many costs including higher taxes, overcrowded schools, health care costs, and on and on. This is a problem that should be addressed by all Americans and it is not exclusively a federal problem as many claim. Indeed every American bears responsibility to uphold the rule of law.

The proposed 'Resource Center' is of great concern because it would promote Lake Worth, Florida and United States as a job magnet that would be an incentive for more illegal immigration. It should be clear that condoning illegal immigration will most certainly solidify the reputation of Lake Worth as Sanctuary City, thus emboldening illegal aliens to entice their friends and relatives to enter to our country illegally.

Box 4219 Hialeah, FL 33014 www.FLIMEN.org To demonstrate our sincerity toward immigration, immigrants, the City of Lake Worth, and the rule of law, FLIMEN hereby announces that we will support the 'Resource Center' with only one condition, that being the independently verifiable use of E-Verify at the 'Resource Center.' E-Verify is a successful federal program where a person's eligibility to work is validated. FLIMEN support would be contingent upon an independent audit by an agreed upon neutral third party. Use of E-verify would be quite easy and inexpensive for The Mentoring Center, Inc. to utilize. The proposed lease between the City of Lake Worth and The Mentoring Center should include the condition of E-verify usage as well an independently verifiable audit. If the City of Lake Worth will adhere to federal law FLIMEN will be happy to meet with your representatives to help with the audit terms.

It is imperative that the City of Lake Worth comply with federal immigration law which is posted at http://www.flimen.org/Section274felonies.htm:

A person (including a group of persons, business, organization, or local government) commits a federal felony when she or he:

* assists an alien s/he should reasonably know is illegally in the U.S. or who lacks employment authorization, by transporting, sheltering, or assisting him or her to obtain employment, or

Thus, the financial support by the City of Lake Worth, without implementation of E-Verify, is clearly a federal felony. It should also be clear that the only real difference between support and opposition of the 'Resource Center' is E-Verify, a program that discriminates only on legality and not on race or culture.

Implementation of E-verify would likely eliminate divisive controversy that will no doubt continue throughout the duration of the 'Resource Center.'

Please implement E-Verify as a condition to the lease with The Mentoring Center, Inc.
